I understand and acknowledge that the foregoing trade secrets are secret, confidential, unique and valuable, and were developed by Laser Energetics over a long period of time and at a great cost and the disclosure or use without the express consent of Laser Energetics will cause Laser Energetics irreparable injury from such appropriation.

I further understand and acknowledge that the proprietary information I have had access to or been exposed to, or will have access to or will be exposed to, regardless whether I believe it to be proprietary or a trade secret cannot be disclosed in writing or verbally, to any person, corporation or other entity without the express written consent of the President of Laser Energetics.

I agree that in the event of a breach or threatened breach by me of this agreement, Laser Energetics is entitled to an injunction preventing me from disclosing any confidential business information of Laser Energetics, from rendering services or sales to any other person or entity to whom such information was disclosed or is threatened to be disclosed, whether or not such person or entity is in competition with Laser Energetics, from contacting or soliciting any customer of Laser Energetics, and/or from acting in any other manner constituting competition to Laser Energetics.

I agree that Laser Energetics is not limited to legal remedies provided herein, and may pursue other actions at law if I breach this agreement.

I acknowledge that this agreement is governed by New Jersey laws and any action at law arising here from shall, if possible, be in Trenton, New Jersey.
